### Session 1 – A New England Community Water Fluoridation Campaign: Using Social Marketing and Community Mobilization for Policy Change

Despite its proven effectiveness at promoting oral health in a cost-effective, equitable manner, community water fluoridation (CWF) is often thwarted, and de-fluoridation efforts are ramping up throughout the country. Largely due to a small but vocal and well organized minority that relies on junk science and appeals to fear-based messaging, fluoridation can no longer win on its scientific merits alone.

With support from the DentaQuest Foundation, Health Resources in Action (HRiA) is implementing a new approach to CWF that mobilizes community support via coalition building and grassroots organizing, and deploys a social marketing strategy to understand and leverage community values. These approaches have been applied with great success in the public health field, but have not been applied to oral health practice and policy. Working with a local campaign coordinator and local coalition, HRiA endeavors to fluoridate two communities in New England -- Hartford, VT and Brockton, MA – implementing this innovative approach.

During this session, participants will learn about activity to date in each community as well as lessons learned.

#### Session 2 – Oral Health in Non-Dental Settings: Three Innovative Programs

Learn about three different programs from around rural New England that integrate oral health into non-dental settings:

Community Health Center of Franklin County has taken the concept of school-based oral health screenings one step further and provides cleanings to children throughout Franklin County. Learn about the rapid growth of this program and how to establish a similar model in your community.

Bi-State Primary Care Association has received funding from the Dentaquest Foundation to Strengthen the Oral Health Safety Net in the VT and NH Federal Qualified Health Centers. Bi-State will discuss local and state level strategies to integrate and maximize opportunities for oral health programs to increase efficiency, access, and integration with primary care.

With the second highest child Medicaid dental utilization rate in the country and no physical access problem, CTDHP is partnering with primary care physicians and OB/GYNs to encourage their patients to seek regular oral health care. To overcome patient reluctance, CTDHP is visiting medical provider offices, educating staff and providing referral pads and oral health kits for patients.

#### Session 3 – Implementing the Tools of Quality Improvement in Dental Practice

The expectation of delivering quality health care is a basic tenant of health care reform and most medical care delivery systems have developed methodologies for defining, tracking and measuring the quality of health care services provided to patients. Dental care delivery systems have begun to define these same concepts within the framework of dental practice. This session will explore various quality improvement initiatives and tools and how they can be successfully used in rural dental practices.

#### Session 4 – Making the Financial Piece Work for Community Health Centers

Finance and funding for Community Health Center's (CHC) dental programs becomes more and more of a challenge as the economy remains volatile and as the Affordable Care Act asks that we create more access for more patients who have more disease and less ability to pay for the care of that disease. Understanding CHC financial strategic planning and how to make that work for you is more critical than ever. This session will teach you about understanding finance, having the right tools to utilize, knowing what a CHC business plan should look like and how to take all of that and create the accountability and clarity to make your program work.

#### Session 5 – Strategies for Addressing the Role of Culture in Access Issues

Enhancing providers' cultural awareness and understanding of the role of culture in access to dental services can increase care and program utilization. Lessons learned from tobacco control can help oral health programs enhance cultural acceptability. The session will discuss research findings, cultural competency trainings for providers, the new Ad Council campaign, and Motivational Interviewing, a technique for connecting with patients. These enhanced programs can provide a model for social change to shift the paradigm in people's thinking about oral health and the importance of caring for their teeth.

#### Session 6 - Creative Recruitment Tactics for Rural New England

The aging of the dental workforce, in New England as in other parts of the country, is making the task of maintaining/growing an adequate dental workforce for rural areas particularly challenging. In this panel discussion you will learn about a number of successful efforts to meet this challenge, including National Health Service Corps initiatives, "dentist ambassadors," pilot financial planning sessions for dentists, creating job shadowing networks and the creation of a program that connects pre-dental undergraduates with dental residents.
